Statutory Consultation

Proposal to establish a resource base at Lyneham Primary School

Introduction

Wiltshire Council proposes to establish a resource base (a Special Educational Needs [SEN] provision) at Lyneham Primary School, Lyneham, Wiltshire. This proposal has been developed in response to the demand for special educational needs provision in the North Wiltshire area.

Should the creation of the resource base be agreed, the council and the school will work together to ensure that all admissions are handled effectively and efficiently.

<u>The Proposal</u>

In accordance with Section 19(1) of the Education and Inspections Act 2006 (as amended by the Education Act 2011) and the School Organisation (Prescribed Alterations to Maintained Schools) (England) Regulations 2013 Wiltshire Council are proposing changes to Lyneham Primary School, to establish a resource base and register it with the Department for Education (DfE).

The SEN designation of the resource base would be Communication and Interaction to support the needs of children who have an Education, Health and Care Plan (EHCP) and would be inclusive of children with autism. The resource base would receive children with SEN from the local area, not limited to the school's mainstream catchment.

The resource base would open in January 2023, initially for a up to 10 places, with the expectation that the resource base would increase the number of places available from September 2023. The Published Admissions Number of the school will remain the same and not be impacted by this proposal.

Wilshire Council are making this proposal to meet the needs of the growing number of children with SEND, particularly in the North Wiltshire area.

The case for establishing a resource base at Lyneham Primary School

Wiltshire Council has a statutory duty to secure sufficient school places for pupils with special education needs (Children and Families Act 2014) and to ensure that these places provide both high quality provision and value for money. The establishment of a resource base at Lyneham Primary School is being proposed for the following reasons:

- Wiltshire Council has identified a demand for additional resource base provision in the North Wiltshire area
- Lyneham Primary School was judged to be a good school by Ofsted at their last inspection in November 2021
- Lyneham Primary School are committed to inclusion and delivering a high-quality SEN provision
- Existing, suitable indoor and outdoor space at the school have been identified for the resource base
- Affordable refurbishment and adaptation work has been agreed between Wiltshire Council and the school to make the identified spaces ideal for resource base provision
- Lyneham Primary School are fully supportive of the proposal

The Outcomes of the Proposal

Wiltshire Council is proposing to establish a resource base at Lyneham Primary School.

We believe that this will:

- Provide additional capacity to manage demand for SEN school places in Wiltshire, particularly in the North Wiltshire area
- Support improved educational outcomes for children with SEN

This proposal is not expected to have any limiting impact on other local provision including local schools but will contribute towards parental choice.

Implementation

Following consultation, the local authority and school will work together to ensure that all admissions are handled effectively and efficiently. Pupils will start at the new resource base from January 2023.

The establishment of a resource base at Lyneham Primary School is part of a wider plan of increased SEN school place capacity across Wiltshire to ensure countywide SEN school place sufficiency.

Costs and Expenditure

Lyneham Primary School will receive SEN place funding for each child placed at the resource base and top up funding for each child which will vary according to the child's needs identified in their EHCP. The school will be responsible for staffing and resources, and the local authority and the school have worked together to financially model the provision to ensure it is affordable and will not impact upon the mainstream school budget.

The capital costs for the agreed refurbishment and adaptations have been costed and will be funded by the local authority from the SEN capital grant.

All statutory consultation requirements relating to these proposals have been complied with.
